Day 1: Tuesday, July 7, 2020 • Departure

Our journey begins as we board our international flight bound for Hamburg, Germany. **Inflight meals**

Day 2: Wednesday, July 8, 2020 • Hamburg – Bremen

Upon our arrival in Hamburg, we meet our coach driver and tour guide and those who toured Schleswig-Holstein. Then we have a typical “Hamburger” lunch. That would be a typical German lunch not a burger and fries. After lunch we embark on a tour of Hamburg to include the neo-renaissance style Hamburger Rathaus (city hall). We also see St. Michael's church, the land mark of the city simply known as “Michel”, stroll along the Jungfernstieg, a popular promenade along the Binnenalster, explore the Old Town with the impressive St. James’ Church. We visit the harbor area then depart for Bremen, the town made famous by the fairy tale stories of the Brothers Grimm and the Bremen Towne Musicians. Dinner is at our hotel tonight **L, D**

Day 3: Thursday, July 9, 2020 • Bremen

This morning a local guide joins us for a walking tour of Bremen. We discover “There once was a man who had a donkey.” as we take in the sculpture of the musicians of the fairy tale. In the Schnoor, the oldest part of Bremen, where we become acquainted with Bremen's history and admire the old burgher houses from the 15th - 18th centuries. This afternoon is free to explore the many museums, visit the art galleries, shop in the markets or take a bike ride. For those interested our

coach driver will be available to take you to the Bremerhaven, a deep sea port founded at the mouth of Weser estuary in 1827, and one of Europe's major gateways to cross the ocean to North America. We visit the German Emigration Center where between 1815 and 1914 some 233 million Europeans emigrated to the United States. Dinner is on our own tonight. **B**

Day 4: Friday, July 10, 2020 • Celle - Kassel

Our day begins with a short drive to Celle, known for its half-timbered buildings. During our exploration of Celle with a local guide we visit the Ducal Palace of Celle, which was built in 1318 and has the only church north of the alps, with completely preserved Renaissance features. Then we continue on to Kassel where we visit the Löwenburg Castle. **B, D**

Day 5: Saturday, July 11, 2020 •

Rothenburg ob der Tauber

Before leaving Kassel this morning, fairy tales come to life as we visit the the Grimm World Center and exhibition. Then it is off to Rothenburg, a well-preserved medieval city, with its ramparts, a city gate, and town hall. Perhaps the most famous town on the “Romantic Road”, Rothenburg is indeed a jewel. We will become acquainted with the ramparts and city center before dinner at our hotel. Afterwards we join the Night Watchman for a private tour as he makes the nightly rounds while he spins the tales the city. **B, D**

Day 6: Sunday, July 12, 2020 • Rothenburg ob der Tauber
Today is a free day in Rothenburg. **B**

Day 7: Monday, July 13, 2020 • Oberammergau
After breakfast we board our coach and drive the Romantic Road stopping in the medieval town of Dinkelsbühl and in Augsburg. Then we continue on to Oberammergau where the Thirty Years' War and the plague of 1632 threatened to wipe out the local population of this small town. The survivors made a pledge that they would perform a passion play every 10 years and no further deaths occurred. **B, D**

Day 8: Tuesday, July 14, 2020 • Oberammergau
We enjoy a relaxed morning in Oberammergau, admiring the bright frescoes that adorn many of the homes and businesses, perhaps shopping for a souvenir woodcarving for which the village is famous. We have options to visit nearby attractions. This afternoon we attend Part I of the Passion Play, the legacy of a vow made by the Oberammergauers in 1633 to enact the Passion story. After dinner we attend Part II. **B, L, D**

Day 9: Wednesday, July 15, 2020 • Garmisch - Munich
This morning we drive to Garmisch Partenkirchen for an unforgettable experience. We see the roof of Germany as we ride the cable car part way up the Zugspitze and then hike down. Afterwards we drive north to Munich, the city of "Gemutlichkeit!!" (Good Cheer) where we will enjoy dinner in a German beer hall. **B, D**

Day 10: Thursday, July 16, 2020 • Munich
This morning our locally guided tour of Munich includes Marienplatz, the Glockenspiel, the Residenz, and Jesuit Church (St. Michael's). We experience the delightful aromas of the Viktualienmarkt then continue on to Nymphenburg Palace. This afternoon is free to explore on our own. Perhaps some will choose to take the train to near by Dachau to remember a moment never to be forgotten. We enjoy a farewell dinner tonight. **B, D**

Day 11: Friday, July 17, 2020 • Return to U.S.
Some of us transfer to the airport this morning, while some continue our German adventure and head west to the Black Forest. **B**

In the event a surcharge is imposed after Ed-Ventures has received a final payment, Ed-Ventures will send an additional invoice for the surcharge amount. Early registration is encouraged.

Currency:

Currency exchange rates fluctuate constantly. In the event of a significant drop in the value of the dollar, we reserve the right to add a currency surcharge to the price of the tour.

Refund/Cancellation Policy:

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. The initial deposit is non-refundable. From the time of 2nd deposit to 121 days before departure a \$100 administrative fee plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. From 120-14 days, a \$300 cancellation penalty plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. Airline tickets once purchased are nonrefundable. Anyone canceling less than 14 days prior to departure will receive no refund.

Purchase of health, baggage, and trip cancellation/interruption insurance is strongly recommended.
