I understand that Blue Horizon Travel & Yacht Charters also known as Blue Horizon Yacht Charters (“BH”) is not the source or supplier (see definition in next sentence) for the travel arrangements I have requested. BH acts solely as an independent travel advisor for any airline, hotel, car-rental company, tour operator, cruise line, or other service provider named in my itinerary (“Suppliers”). BH is not responsible for acts or omissions of the Suppliers or their failure to provide services or adhere to their own schedules, failure to provide services or refunds, financial default, or failure to honor future trip credits. BH has no knowledge beyond that available to the public regarding the financial condition of the Suppliers and no liability for recommending a trip credit in lieu of a refund.

BH assumes no responsibility for and shall not be liable for any refund, personal injury, property damage, or other loss, accident, delay, inconvenience, or irregularity which may be caused by any wrongful or negligent acts or omissions on the part of any other party not under BH’s control or any acts of God, acts of government, unsafe conditions, terrorism, health hazards including pandemics, illness, weather hazards, or the suitability for a disabled person of any portion of any trip. You hereby release BH from all claims arising out of any listed circumstance covered in this paragraph.

I will review my travel documents for accuracy upon receipt and notify BH immediately should I notice any discrepancy. I understand that changing any aspect of my travel arrangements may result in an increase in price. Travel arrangements involving airline, tour or cruise components are subject to supplemental price increases that may be imposed by the Supplier and/or government between your initial and final payments. No change in airfare will occur after ticketing. Suppliers have their own contracts covering cancellation penalties and other terms and conditions. You are encouraged to visit the websites of these Suppliers to read these terms and conditions. By signing below, you are consenting to those terms and conditions.

BH has no knowledge beyond that available to the public regarding unsafe conditions during travel or at destinations, health hazards, weather hazards, or climate extremes at locations to which you may travel. For information concerning such dangers, we recommend contacting the Travel Warnings Section of the U.S. State Department at (202) 647-5225 or <http://www.travel.state.gov/>, click on "Find International Travel Information" then click on "Country Information", and fill in the name of the destination country. BH will provide guidance on passport, visa, vaccination and other entry requirements, but you assume full and complete responsibility for checking and verifying any and all passport, visa, vaccination, or other entry requirements of your destination(s), and all conditions regarding health, safety, security, political stability, and labor or civil unrest at such destination(s). You hereby release BH from all claims arising out of any listed circumstance covered in this paragraph.

**BH** strongly recommends travel insurance. I understand that I may purchase it through them to cover certain risks inherent in travel such as bankruptcy of a Supplier and the inability to travel due to a medical or personal emergency. I further understand that travel insurance does not cover all risks and generally will not cover expenses due to trip cancellation or interruption due to acts of God, acts of government, unsafe conditions, terrorism, health hazards including pandemics, and weather hazards.
